There is no cost for this registration. The legal name and address of the entity applying, and the DUNS number must be the same as the application for funding. When registering or updating the sam.gov registration, the applicant must opt-in for public view.
- The Conflict-of-Interest MUST be completed by all board members of officers, all senior staff and all staff directly involved in the proposed CDBG activity/program and included with the application.
- Applicants should demonstrate a clear understanding of all aspects of proposed project and provide detailed documentation of such. (Secured leveraged funding, cost estimates and design drawings from engineering firms, long term maintenance plans, etc.)
