

**NOTICE OF RUNOFF ELECTION
SPECIAL ELECTION FOR OFFICE OF CITY OF CHARLESTON
COUNCILMEMBER FOR DISTRICT 1
JANUARY 25, 2022**

The City of Charleston Municipal Election Commission hereby gives notice that the City of Charleston will conduct a Runoff Election on Tuesday, January 25, 2022 to fill the councilmember seat for the office of City Council District 1. This is a non-partisan, at-large, municipal election conducted pursuant to SC Code of Laws § 5-15-62. There shall be no party affiliation placed on the ballot. **Term of office will expire December 31, 2023, or until such time as the newly elected council member takes office.**

Registered voters who cannot vote in person may be eligible to vote by absentee ballot. Absentee ballots may be obtained from the Charleston County Board of Elections and Voter Registration or the Berkeley County Voter Registration and Elections. In Charleston County, you may call 843-744-8683 or send an email to absentee@charlestoncounty.org to inquire about the availability of absentee ballots. In Berkeley County, you may call 843-719-4058 or send an email to webvre@berkeleycountysc.gov to inquire about the availability of absentee ballots.

Beginning at 9:00 a.m. on Tuesday, January 25, 2022, the Charleston County Board of Elections and Voter Registration will begin the examination of the absentee ballot return envelopes at the Elections Office, 4367 Headquarters Road, North Charleston, SC, and the Berkeley County Board of Elections and Voter Registration will begin the examination of the absentee ballot return envelopes at the Voter Registration Office, 1003 Highway 52, Moncks Corner, SC.

On Thursday, January 27, 2022, at 12:00 p.m., the Municipal Election Commission will hold a public hearing at the Charleston County Board of Elections office, 4367 Headquarters Road, North Charleston, SC, to determine the validity of all ballots challenged in this election and certify election results.

Any protest of the election results must be submitted by the candidate by filing a written notice of such contest together with a concise statement of the grounds therefor with the Municipal Election Commission within forty-eight hours after the closing of the polls. Any protest will be heard by the Municipal Election Commission at a public hearing on Friday, January 28, 2022, at 9:00 a.m. at the Charleston County Board of Elections office, 4367 Headquarters Road, North Charleston, SC.

This Municipal Election will be held under the rules pertaining to Photo ID requirements to vote pursuant to SC Code of Laws § 7-13-710. The polls will be open on January 25, 2022, from 7:00 a.m. until 7:00 p.m.
