#### **POULTRY USE APPROVAL FORM**

The keeping of residential chickens is a conditional use on properties that are at least 10,000 square feet in size and zoned in suburban single-family residential districts (R-1, R-2, R-1MM, and certain Planned Development Districts). Applications are approved upon demonstrated conformance to the prescribed standards found in Sec. 11.3.4. <u>Roosters over the age of 3 months are prohibited.</u>

This form is not applicable to those individuals who desire to keep residential chickens on properties that zoned in agricultural or rural zoning districts, though separate conditions may be applicable in such cases. Please inquire within the Planning and Zoning Department for additional information.

Please fill out the requested information, read and initial the criteria and stipulations, sign the application, and provide a site plan of the subject property, depicting any proposed improvements associated with the request to keep residential chickens. <u>A separate construction permit may be required for any accompanying construction activities.</u>

## **POULTRY USE APPROVAL FORM**

BELOW ARE THE MINIMUM CRITERIA AND STIPULATIONS TO QUALIFY FOR THE KEEPING OF RESIDENTIAL CHICKENS. PLEASE READ EACH STATEMENT CAREFULLY, INITIAL, AND SIGN ON PAGE 3 TO ACKNOWLEDGE THAT YOU AGREE TO COMPLY WITH ALL PROVISIONS OF THIS FORM.				
	Section	Initial		
Α.	Permitted as an accessory use to a permitted residential use only			
Β.	Minimum lot size of 10,000 square feet of any residential parcel is required for the keeping of up to two (2) chickens; and			
C.	For each additional 4,500 square feet of any residential parcel, one additional hen may be kept up to a maximum of eight.			
D.	No male chickens (roosters) over the age of three months are permitted.			
E.	No chickens may run at large. All chickens must be contained with the property boundary.			
F.	The chickens shall be provided a covered, predator-proof chicken house that is thoroughly ventilated, and of sufficient size to admit free movement. The chicken house must be adjacent to and provide free access to the chicken enclosure. Any heat source or electrical facilities installed in a chicken house must comply with all adopted building and electrical codes of the County.			
G.	Chickens shall be secured within the chicken house from sunset to sunrise.			
Н.	Chicken enclosures and houses must be kept in a neat and sanitary condition at all times and must be cleaned on a regular basis so as to prevent offensive odors.			
١.	Chickens shall have continuous access to adequate food and water.			
J.	Stored feed must be kept in a rodent-and predator-proof container.			
К.	Chickens shall be maintained in a healthy condition. Ill chickens shall either receive appropriate medical care or be culled.			
L.	No chicken house shall be located closer than 20 feet to any structure inhabited by someone other than the chicken owner, custodian, or keeper, and not closer than ten feet to any property line. Chicken houses may be movable but must comply with all standards of this section.			
М.	No chicken shall be kept in a manner so as to create noxious odors or noise of a loud, persistent and habitual nature.			
Ν.	No chickens shall be slaughtered within the public view.			
Ο.	Enforcement. Upon receiving a complaint of a possible violation, the code enforcement officer will investigate and determine if a violation of this section exists. If the animal control officer determines a violation exists, the officer may serve upon the permit holder or the owner or lessee of the property a written notice of violation and an order to take corrective action, may issue a warning, or may immediately issue a violation notice.
