The Tall Pines Special Tax Commission (TPSTC) meeting came to order on Tuesday, December 8, 2020 at 7:08 pm, for the purpose of paying bills, and discussing agenda items.

TPSTC Members present: Terry Hess, Neal Menkus, Nelson Montalvo, Jim Royce

The September 2020 minutes were presented and unanimously approved.

The October 2020 Treasurer's Report was presented and unanimously approved.

The November 2020 Treasurer's Report was presented and unanimously approved.

The December 2020 Treasurer's Report was presented and unanimously approved.

TPSTC discussed renewing insurance for 2021, using Applachian Underwriters - General Commercial Liability (\$7661) and Directors and Officers Coverage (\$1527), total = \$9188

TPSTC agreed to transfer \$10,000 from the Capital Funds account to pay this before February, since we don't expect to meet again until March

On the advice of Councilperson Tommy Newell, the TPSTC voted to resume cleaning and maintaining the Clubhouse on a monthly basis, and performing periodic checks of the site for break-ins, water leaks, or other damage.

When asked if a contract was needed for this work, Tommy Newell did not say it was.

Speed Humps - TPSTC intends to attend Berkeley County January 4, 2021 meeting. Jim Royce will communicate to neighborhood.

Security Cameras at Entrances - currently at south (but needs to be re-worked) and middle entrances, also install a setup at north entrance

Two Security cameras at the Clubhouse may need to be replaced.

Clubhouse Playground Improvements

Completed: swings and slides replaced, new mulch added, and the entire structure repainted

Planned: 3 or 4 picnic tables, shade structures, trees, signs

Duck Pond/Ball Field area improvements

Berkeley County agree cut vegetation back to water? plant w/native species to control erosion? timeline, community learning event?

Ballfield: clear grass, cover with clay, repair backstop, shed, drag & line equipment

Playground & Exercise Trail & Areas: fence, 10 Station Fit-Trail (expandable to 20),

additional children's playground, tetherball court, 4-square court, hopscotch area

TPSTC intends to install new signs on the Cans for Kids trailer - Nelson Montalvo agreed to lead this effort. TPSTC discussed renovating the Clubhouse before Spring. Potential work includes replacing windows and air conditioning, and redoing the floor and patching holes in walls.
