

## TECHNICAL REVIEW COMMITTEE (TRC) 2024 CALENDAR

Preliminary Subdivision and Infrastructure Construction Plans (PLPR) and certain \*Final Plat (PLFP) submittals that are contained in a Development Agreement adopted prior to December 14, 2020 require review at TRC (\*initial submittals and major revisions only).

All meetings will begin at <u>1:30pm via Video/Audio Conference on the second</u> <u>Wednesday of each month unless otherwise noted</u>. Any changes to meeting times will be posted as early as possible outside the Planning Department.

To be placed on a regularly-scheduled TRC meeting agenda, a complete submittal package must be received by the deadline provided below. Applicants are encouraged to submit their <u>Development Review Application</u> at least two (2) business days ahead of the close of the intended submittal period so that all materials necessary for review can be uploaded in the <u>E-Review</u> <u>Portal</u> by the required deadline. Please refer to the submittal instructions provided by the Plan Case Administrative Specialist at the time of application submittal and available on the <u>Development</u>
